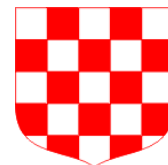

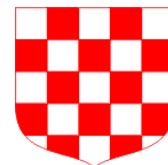

The Australian Privacy Principles apply to and are adhered to by The Australian Croatian Club Limited. Management and Staff of The Australian Croatian Club Limited respect your privacy and any personal information which it may collect from you for the purposes of providing our members with all of its facilities / services. We are committed to protecting this information.

We will collect personal information from you, if you:

- Apply to become a member of The Australian Croatian Club Limited;
- Request renewal of your membership to The Australian Croatian Club Limited;
- When you use Club facilities and services, or to register for events, promotions or competitions;
- If you ask to be included on a mailing list; or
- If you submit your personal information to us for any other reason.

We are required to collect, retain and disclose some information under Australian Law (such as GST Legislation, The Liquor Act 2010, The Associations Incorporation Act, and The Corporations Act).

If you do not provide us with certain information we may be unable to accept your application for membership or provide you with access to our venues or services. Members are taken to consent to direct marketing upon acceptance of their membership / renewal applications. Please contact management on 6248 8782 should you wish to remove your name from any direct marketing lists. If you do not contact us directly, we will assume that your consent stands.

Guests of our members, temporary members and all other persons other than financial members are required by law to sign in upon arrival at The Australian Croatian Club Limited. Please be aware that information you provide when signing in may inadvertently be observed by members and other guests of the Club.

In the interests of security and safety, and the comfort of members and guests, the Club also operates video cameras within the Club premises and may collect personal information in the course of investigating complaints or pursuing disciplinary proceedings. The footage from such cameras may be provided to law enforcement bodies. All persons who enter The Australian Croatian Club Limited are taken to consent to being recorded on video, and the Club using the video to protect its interests.

Your information may be used for demographic data and aggregate use by The Australian Croatian Club Limited, its partners or our advertisers. This information is not linked to any personal information which could identify you. Please note, the Club may not be able to provide you with all of its facilities / services, or do business with you should you elect not to provide all of the requested information.

We will use your personal information to keep you informed of the Club's services or those of our related entities or business partners, or Club's with which we have reciprocal arrangements (direct marketing):

- To have them send you similar information, to provide third party service providers or others (Australian or overseas) that help provide a product, facility or service of the Club to you.
- To provide information to our advisers (i.e. lawyers or accountants) if necessary and as permitted by the Australian Privacy Principles.
- To store or transfer your information to a related entity (Australian or overseas) and to fulfil our contractual duties (if applicable), and enforce your contractual duties (if applicable) to the Club.

The Australian Croatian Club Limited's website contains links to other websites and organisations. We are not responsible for the privacy principles of other entities. If these links take you to chat rooms, forums, message boards or similar communications, your personal or sensitive information may be made public.
